If not otherwise specified on the herbicide label, fill the tank half full add Sure Up™ at the recommended rate, add remainder of water and then the recommended rate of herbicide. Sure Up™ adjuvant increases the solubility of sulfonyl urea herbicides and provide the surfactant functions of sticking, spreading and wetting of the sprayed foliage. Sure Up™ is a surfactant and a water conditioner that increases the pH of the spray tank. Use Sure Up™ as you would use any 90% nonionic surfactant. Use rates of Sure Up™ surfactant should be 1 to 2 quarts per 100 gallons of spray solution. The concentration of Sure Up in the spray tank cannot exceed 25% of the total amount of formulated herbicides(s). Not for use with insecticides and fungicides. **NOT FOR AQUATIC USE.**

<b>FIRST AID</b>
